Our fee ranges vary depending on the application being made, the complexity of the matter, and the experience of our specialist advisor assisting you. We agree the fee in advance to give you peace of mind.

Our fee includes:

- Representation at the police station, magistrates court and crown court and any other recognised location where your legal rights are being observed, such as Home Office, local authority, detention centre, British transport police office etc
- Consultation about the alleged offence / offences in detail and confirming the most appropriate action
- Giving you advice about the criminal procedure rules and elements of the offence / offences.
- Advice on jurisdiction and legislation
- Advising on any issues raised by any evidence served by the crown prosecution service, probation or local authority
- Where necessary, helping you obtain further evidence (such as medical records, crime scene photographs) including taking statements of any witnesses;
- Drafting legal representations such as bail applications, certificate of readiness, defence case statement, s9 and s10 statements
- Assistance in completing and submitting applications forms

Initial Consultation

- **Police station attendance**

On average, this type of work takes between 2-4 hours to complete per attendance. The average costs are between £500-£2000 depending on the location of the police station and the fee-earners hourly rate. All figures exclude VAT.

- **Magistrate court**

On average, this type of work takes between 15-50 hours to complete per matter. The average costs are between £2,700-£5000 depending on the fee-earners hourly rate and complexity of the case. All figures exclude VAT.

- **Crown court**

On average, this type of work takes between 40-100 hours to complete per matter. The includes all attendances relating to magistrate court. The average costs are between £15,000-£500,000 depending on the fee-earners hourly rate and complexity of the case. All figures exclude VAT.

- **Appeals**

On average, this type of work takes between 5-15 hours to complete per application. The average costs are between £1,500-£5,000 depending on the fee-earners hourly rate and complexity of the case. All figures exclude VAT.
