## **Immigration Fees**

Our fee ranges vary depending on the application being made, the complexity of the matter, and the experience of our specialist advisor assisting you. We agree the fee in advance to give you peace of mind.

Our fee includes:

- Consultation about your circumstances in detail and confirming whether this is the most appropriate application for you to make and what other options may be available to you;
- Giving you advice about the requirements of the Immigration Rules, timescales and whether you meet the criteria.
- Advice on documents needed in support of application
- Assistance in preparing and checking documents
- Advising on any issues raised by the documents and how to address these
- where necessary, helping you obtain further evidence (such as medical records and bank statements), including taking statements of any witnesses;
- Attendance at a Home Office interview if you are requested by the Home Office.

## Initial Consultation
